**Subject: Visa Application Procedure for Delegates and Observers for the 9<sup>th</sup> World Junior Wushu Championship**

We are pleased to inform that the Wushu Federation of Brunei Darussalam will facilitate the visa application for all delegation inclusive of observer. As per the guidelines provided by our immigration department, **all delegates are to apply for the Professional Visit Visa** for this event to enter Brunei.

However, observers from countries with existing visa exemption or visa-on-arrival arrangements for entering Brunei are exempted from applying for the Professional Visit Visa. They may enter Brunei under the applicable visa exemption or visa-on-arrival rules.


We kindly require delegates from each country or region to provide the following details:

No.	
1.	Confirmation letter from the organization which consist of all delegates name as passport, passport number, along with a name list with passport numbers and birth dates.
2.	Completion of the Brunei Visa Application Form (as per attached) with digital passport size photo <b><i>*Please be informed that we have filled in the Visa Application Form on your behalf under the 'Contact Address in Brunei'.</i></b> The remaining sections will need to be filled out by the team.
3.	Completion of the Form 8. (As per attached) <b><i>*Please be informed that we have filled in the form 8 on your behalf under the 'Name and Address of the Local Sponsor.'</i></b> Kindly leave blank on the <b><i>i. N.R.I.C Number ii. Place of Issue iii. Date of Issue iv. Date v. and signature of Sponsor.</i></b> The remaining sections will need to be filled out by the team.
3.	Scan copy in PDF format of the passport information page (with photo), valid for not less than 6 months.

We kindly request the International Wushu Federation to disseminate this information to all member federations to ensure that participants and observers are informed well in advance of the visa requirements. **Please take note that the visa application process takes approximately 3 – 4 weeks. Therefore, the submission should be made as soon as possible.**

Thank you for your attention to this matter. We look forward to welcoming the delegation to Brunei Darussalam for the 9th World Junior Wushu Championship.
